The migration to the enhanced Empower recordkeeping platform will begin after market close on Friday, February 2, 2024

Here is an update on completed activities, a preview of upcoming key milestones and information that will help make your migration go as smoothly as possible.

Completed activities

- Migration kick-off webinar in June. Watch the replay.
- A Plan Service Center website security access email was sent to select HR contacts in late December.
- Payroll packet emails containing payroll guides are being distributed from early January through mid-January.

Upcoming milestones

- All incoming payroll files and their respective funding must be received by Tuesday, January 30 at 1 p.m. Eastern time in order to be processed prior to the migration.
- Participants won't be able to make transactions in their accounts beginning at 4 p.m. Eastern time on Thursday, February 1, 2024, through Tuesday, February 6, 2024.
- Plan forms are changing and the last day to use the current forms is March 8, 2024. Any outdated forms received after March 8 will not be accepted. The NC 401(k) and NC 457 Plans' new forms will become available on the Plan Service Center, Empower's plan administration website, post-migration.




